Scholarship Procedure Lee's Summit CARES parenting workshops

Lee's Summit CARES is committed to making parenting programs available to community members regardless of ability to pay. Scholarships are funded through the city of Lee's Summit to families who meet low to moderate income criteria and reside within the Lee's Summit, R-7 school district boundaries. An individual may qualify for a scholarship who does not meet income criteria, but due to their unique circumstances, needs financial assistance. These scholarships are determined on a case by case basis. Payment plans are also available.

To qualify, applicants must:

- 1. Complete and sign the *Scholarship Request Form*.
- 2. Provide proof of identity- picture ID, such as a driver's license.
- 3. Show proof of income. Examples include; a copy of a recent pay stub, previous year's tax return, disability or unemployment check.

***Copies can be made at ReDiscover.

It is the responsibility of the scholarship applicant to ensure that all information is received by Bev Hatley, at ReDiscover, prior to the beginning of the program. Applicants CAN NOT attend the program until this process is complete and the applicant(s) is determined eligible.
